## Professional Documents

✓ Trade license, memorandum of article, VAT, IRC etc. (for Business Person) - Clearly scanned soft copies are required	✓ No objection certificate from the employer granting leave for the specified period (for Employees) - Clearly scanned soft copies are required
✓ Pay Slip, Salary certificate (for Employees) - Clearly scanned soft copies are required	✓ Visiting Card - Clearly scanned soft copies are required
✓ Business Letter head - Clearly scanned soft copies are required	✓ GO & Note Verbal for official passport holders - Clearly scanned soft copies are required

## Financial Documents

✓ Bank Statement (personal or business) showing consistent history for last 6 months (recent) - Clearly scanned soft copies are required	✓ Bank Solvency Certificate - Clearly scanned soft copies are required
✓ Copies of documents showing other funds available - such as FDR, Saving certificate, Share Statement etc. (if available) - Clearly scanned soft copies are required	✓ Monthly income and expenditure of applicant (amount needed) - Clearly scanned soft copies are required
✓ Income Tax Certificate - Clearly scanned soft copies are required	✓ Valuation of other Assets (if any) - Clearly scanned soft copies are required

## Additional Documents

✓ Personal Invitation letter with invitee's passport copy, bank statement, tenancy agreement, utility bill - Clearly scanned soft copies are required

✓ For business visit: Business Invitation letter - Clearly scanned soft copies are required

✓ Student ID card & leave letter from school (For Student) - Clearly scanned soft copies are required

✓ Utility Bill - Clearly scanned soft copies are required

## Important Notes

- ! Processing time: 15-30 working days
- ! Biometric (fingerprint) appointment required at VFS
- ! Monthly income and expenditure details required
- ! Family details must be complete (parents, spouse, children)
- ! Residential address history needed
- ! Financial documents should demonstrate strong ties to Bangladesh
- ! Invitation letter with supporting documents from UK resident required
- ! Visa approval is subject to UK embassy decision
- ! Visa fees are subject to change at any time, depending on the respective embassy
